# PIZZA 73 ® "SUPER 73 SCRATCH & MATCH" CONTEST OFFICIAL CONTEST RULES

#### **HOW TO PLAY:**

Each participant who makes a minimum \$5.99 subtotal purchase at participating Pizza 73 locations in Alberta, British Columbia and Saskatchewan during the Contest Period, or who sends a mail-in entry request without making a purchase by the mail-in entry deadline, will receive one (1) "Super 73 Scratch & Match" card per order (while supplies last), which will have a scratch window which he or she must scratch to find three (3) or four (4) matching icons to be a potential instant winner. Four (4) matching icons produce a winner of one (1) of the corresponding Grand Prizes, while three (3) matching icons produce a winner of one (1) of the corresponding Food Prizes. Winners of the grand, second, and third prizes must correctly answer a four part mathematical skill-testing question, administered at time of redemption, in a time limited way, without assistance or the use of a calculator. All prizes must be redeemed by the date specified on the winning card otherwise prize will be forfeited.
