MLB[®] World Series[®] Presented by Pizza Pizza Limited **Official Contest Rules**

AGREEMENT TO OFFICIAL CONTEST RULES

Participation in the MLB[®] World Series[®] Presented by Pizza Pizza Limited (the "**Contest**") constitutes full and unconditional agreement and acceptance of these official Contest rules ("the "**Contest Rules**"), which are final on all matters relating to the Contest. NO PURCHASE IS NECESSARY to enter the Contest. The Contest is sponsored by Pizza Pizza Limited ("**Pizza Pizza**" or the "**Contest Sponsor**").

The Contest will run from 11:00 a.m. Eastern Time ("**ET**") on August 27, 2018, and close at 11:59 p.m. ET on Sunday, September 30, 2018 (the "**Contest Period**").

There are two (2) methods of entry outlined below.

1. Method of Entry

Method of entry #1 – Via Online Ordering/Mobile App Ordering

During the Contest Period, eligible entrants who order online via the Pizza Pizza website or via the Pizza Pizza mobile app for delivery in Ontario, Manitoba, Saskatchewan and/or Nova Scotia in Canada ("**Participating Territories**"), will receive a unique code with their order link to use to fill out the online/mobile app entry form. To be eligible for entry into the Contest, all Pizza Pizza online orders or Pizza Pizza mobile app orders must be purchased and delivered to a location within the Participating Territories during the Contest Period. Only one (1) entry per person per day during the Contest Period is permitted, regardless of method of entry.

If you do not receive the unique code with your order, please contact *contests* @*pizzapizza.ca* with your receipt details within 72 hours of your order to request a code.

Method of Entry #2 – *No Purchase Necessary*

During the Contest Period, submit a minimum one hundred and fifty (150) word handwritten essay describing your favourite MLB[®] World Series[®] moment along with your name, address, day and evening telephone numbers (including area code) in an envelope with proper postage affixed and sent to: "**MLB[®] World Series[®] Contest Presented by Pizza Pizza**", 500 Kipling Avenue, Toronto, Ontario M8Z 5E5, Canada or via email to *contests*@*pizzapizza.ca*. Entries must be received during the Contest Period to be eligible. Pizza Pizza and the MLB Entities are not responsible for lost, late, incomplete, illegible, damaged, destroyed, postage due, or misdirected entries. Each entry must be submitted in a separate envelope. No bulk mailings will be accepted. Only one (1) entry per person per day during the Contest Period is permitted, regardless of method of entry. All entries will become the property of the Contest Sponsor and will not be returned. Entries which are incomplete or fraudulent are null and void. The Contest Sponsor and the MLB Entities (defined under section 4 herein) do not accept any responsibility for incorrect or inaccurate capture of entry information, including (but not limited to), malfunction, human error, lost/delayed/garbled Internet/e-mail transmission, omission, interruption, deletion, defect, or failures of any telephone, technical, network, online, or hardware or software or any combination hereof. Entries must be submitted from a valid e-mail account that may be identified by reverse domain name search. By submitting his/her personal information through his/her Pizza Pizza online/mobile app profile or his/her no purchase entry submission, the entrant consents to the Contest Sponsor storing and using his/her personal information for the purpose of administering this Contest in accordance with these Contest Rules and the Contest Sponsor's privacy policies, available at *http://www.pizzapizza.ca/privacy-policy*. Personal information will not be used for any other purposes without the entrant's consent.

2. Potential Winner Selection and Odds

A random draw will be conducted from all online/mobile app ordering entries and no purchase necessary entries, at Pizza Pizza at 500 Kipling Avenue, Toronto, Ontario M8Z 5E5, Canada, on November 1, 2018 at approximately 11:00 a.m. ET (the "**Contest Draw Date**") to select the potential winner (the "**Selected Entrant**"). The Selected Entrant will be contacted by telephone, on the telephone number associated with his/her Pizza Pizza online/mobile app ordering entry or as indicated on the no-purchase entry form.

The odds of winning the Prize depends on the total number of eligible entries received during the Contest Period.

3. Prize

The Winner (defined below) will receive the following prize ("**Prize**"), which is subject to section 6 herein:

- a) Coach class flights for the Winner and three (3) guests ("Guest(s)") from a major international airport near the Winner's place of residence, as determined by Pizza Pizza in its sole and absolute discretion, to the city hosting a 2018 MLB[®] World Series[®] Presented by Pizza Pizza game (the "Game") for which Game tickets are awarded ("Host City");
- b) Standard hotel accommodations for four (4) (the Winner and Guests) for three (3) days and two (2) nights on dates close in proximity to the date of the Game for which the Game tickets are awarded, in the Host City at a hotel to be determined by the Contest Sponsor in its sole and absolute discretion (i.e. two (2) standard hotel rooms, double occupancy, including room rate and tax only); and
- c) Four (4) tickets for use by the Winner and Guests to attend the Game, to be determined by the Contest Sponsor in its sole and absolute discretion.

The approximate retail value ("**ARV**") of the Prize is seven thousand five hundred Canadian dollars (\$7,500.00 CAN).

The Contest Sponsor and the MLB Entities make no warranty, guarantee or representation of any kind concerning the Prize (or any portion thereof) and disclaim any implied warranty.

<u>Prize Conditions:</u> If the Winner elects to partake in any or all portions of his/her Prize with no Guests or less than the stated number of permitted Guests, the Prize will be awarded to the Winner less tickets and/or hotel accommodations for the Guests not in attendance, and any remainder of the Prize will not be awarded to the Winner and will be forfeited. The Winner will not be eligible for any further or alternative compensation in lieu of the Winner's Guests partaking in the Prize. All elements of the Prize must be redeemed at the same time, and no changes will be permitted after confirmation of Prize redemption.

If the Winner is under the age of eighteen (18), he/she must be accompanied by an adult of at least twenty-one (21) years of age in order to check into the hotel forming part of the Prize. Unless a child or ward of the Winner or one of the allotted Guests, each Guest must be eighteen (18) years of age or older (and of legal age of majority in his/her jurisdiction(s) of residence) as of the date of departure and must travel on the same itinerary and at the same time as the Winner. Specific travel dates and arrangements are subject to air travel, holiday, blackout dates, and other Prize and travel restrictions. The Winner and Guests are responsible for obtaining, at their own expense, any necessary travel documentation (i.e. valid visas, passports, etc.) prior to travel. ARV of the Prize may vary depending upon the points of departure, and/or airline fare fluctuations; any difference between stated ARV and final value of Prize will not be compensated.

The Prize consists only of the elements expressly set forth above; no other elements or expenses (including, without limitation, insurance, meals, ground transportation, transfers to and from airports, phone calls, gratuities, incidentals, souvenirs, gasoline, etc.) are included in the Prize. All such expenses are the sole responsibility of the Winner and Guest. The Winner is responsible for any air travel taxes and/or expenses, including applicable departure taxes or fees, inspection charges, baggage charges and security charges. Seat locations at the Game shall be determined in the sole and absolute discretion of the Contest Sponsor. The Game dates and times are determined in the sole and absolute discretion of the Office of the Commissioner of Baseball and/or the applicable Major League Baseball Club, as applicable, and may be subject to change. The terms and conditions of the tickets awarded as part of the Prize will govern in the event the Game, event or exhibition as defined by Major League Baseball, is not played or held, as applicable, due to weather conditions, an act of God, an act of terrorism, civil disturbance any other natural disaster outside their control, work stoppage, lock-out or other labour dispute, or any other reason that may cause the cancellation or postponement of the Game, event or exhibition. The Winner and his/her Guests agree to comply with all

applicable ballpark and venue (as applicable) regulations in connection with the Prize. The Contest Sponsor and the applicable MLB Entities reserve the right to remove or to deny entry to the Winner and/or any of Guests who engage(s) in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person at the Game, event or exhibition.

Released Parties (as defined under section 5 herein) will not be responsible for weather conditions, acts of God, acts of terrorism, civil disturbance, any other natural disaster outside their control, work stoppage, lock-out or other labour dispute, or any other reason that may cause the cancellation or postponement of the Game, event or exhibition. Game, event and exhibition tickets awarded may not be resold or offered for resale or used for any commercial or promotional purpose whatsoever. Any such resale or commercial or promotional use may result in disqualification and Prize forfeiture, and may invalidate the license granted by the Game, event or exhibition tickets.

4. Eligibility

The Contest is strictly open to legal residents of the Participating Territories. The following persons are not eligible to win the Prize: employees, officers, or directors or their immediate family members or those domiciled with such persons of the Contest Sponsor, the MLB Entities as defined in this section 4, or any of their respective affiliates, promotional agencies and independent judging organization of the foregoing entities. The "**MLB Entities**" shall mean the Office of the Commissioner of Baseball ("BOC"), its Bureaus, Committees, Subcommittees and Councils, MLB Advanced Media, L.P., Major League Baseball Properties, Inc., The MLB Network, LLC, the Major League Baseball Clubs ("Clubs"), each of their parent, subsidiary, affiliated and related entities, any entity which, now or in the future, controls, is controlled by, or is under common control with the Clubs or the BOC, and the owners, general and limited partners, shareholders, directors, officers, employees and agents of the foregoing entities. The Contest is void outside the Participating Territories, and where prohibited or restricted by law.

5. Winner Declaration

Before being declared a winner, the Selected Entrant must satisfy the eligibility requirements in section 4 and the following (and upon verification of eligibility and compliance with these Contest Rules, the Selected Entrant will be declared the official winner of the Contest (the "**Winner**")): (i) the Selected Entrant must correctly answer a time-limited mathematical skill-testing question without assistance or the use of a calculator, administered at the time of contact or within forty-eight (48) hours of the first attempted contact by telephone; and (ii) the Selected Entrant and Guests must sign and return (a) a waiver, (b) Declaration of Compliance with the Contest Rules and a Release of Liability, releasing the Released Parties, as defined in this section 5 (the "**Declaration and Release**"), and (c) a publicity release (the "**Publicity Release**") (except where prohibited) which confirms, among other things, that the Selected Entrant: (i) releases and holds harmless, to the full extent of the law, the Contest Sponsor, the MLB Entities and each of their respective affiliates, promotional agencies and independent judging organization of the foregoing entities, and each of their respective directors, officers,

owners, partners, employees, agents, mandataries, franchisees, subsidiaries, affiliates, associated companies, representatives, successors and assigns (collectively, the "**Released Parties**" or "**Releasees**") from any and all liability in connection with: (a) the Selected Entrant and/or Guests' participation in the Contest; (b) the acceptance and use of the Prize (or any portion thereof) awarded in the Contest; (c) the administration of the Contest by the Contest Sponsor, including (without limitation) the selection of the Winner or the distribution of the Prize awarded in this Contest; and (d) a waiver, Declaration and Release and Publicity Release (except where prohibited) must be returned on or before the date indicated on said documents or the Prize will be forfeited and redistributed at the Contest Sponsor's sole and absolute discretion by random draw from among all remaining eligible entries.

If the Selected Entrant cannot answer, or incorrectly answers, the mathematical skilltesting question, or fails to respond to the notification within forty-eight (48) hours of the first attempted contact by telephone made to the phone number associated with the Selected Entrant's Pizza Pizza online/mobile app ordering entry or no purchase necessary entry, or if the Contest Sponsor is otherwise unable to contact the Selected Entrant within such time, or if the Selected Entrant refuses or fails to return the executed waiver, Declaration and Release, and Publicity Release (except where prohibited) for the Selected Entrant and behalf of their Guests, or if the Selected Entrant otherwise does not meet any of the Contest eligibility requirements, or satisfy any other Contest conditions, the Selected Entrant's entry will be disqualified and another entry may be selected as the potential winner of the Prize, in the Contest Sponsor's sole and absolute discretion, by random draw from among all remaining eligible entries. Time permitting, the process may continue until the Winner of the applicable Prize has been selected and confirmed at the Contest Sponsor's sole and absolute discretion.

6. Miscellaneous

The Prize must be accepted as awarded and no Prize substitutions of cash transfer or otherwise will be permitted by the Winner, albeit the Contest Sponsor may make Prize substitutions of equal or greater value at its sole and absolute discretion. Prizes may not be exactly as shown in the Contest publicity or promotional materials. No telephone or other correspondence will be entered into regarding the Contest except with the Selected Entrant and Winner.

In order to claim the Prize, the Winner will be required to consent to the use of his/her name, image, photograph, voice statement(s) and city of residence, without further compensation, for any and all publicity purposes, commercial or otherwise, in all media used by the Released Parties, unless prohibited by law.

The Contest is subject to all applicable federal, provincial and municipal laws and regulations, and shall be governed by the laws of the Province of Ontario and the federal laws of Canada applicable therein.

By participating in the Contest, each Contest entrant agrees to be bound by the Contest Rules, any regulations and all decisions made by the Contest Sponsor, which decisions

are final with respect to all matters relating to the Contest, including (without limitation) the selection of the Winner.

The Winner and Guests agree to hold harmless and indemnify the Released Parties against any and all liability, damages or causes of action (however named or described with respect to or arising out of either: (i) the Winner's participation in the Contest; (ii) the receipt or use or misuse of the Prize (or portion thereof) awarded herein; or (iii) the administration of the Contest (including Winner selection) and distribution of the Prize awarded herein.

Each Contest entrant hereby releases, waives and discharges any and all claims of damage, loss or causes of action (including negligence), and including (but not limited to) death, personal injury or loss or damage to property, which the entrant or any of the entrant's representatives, heirs, next of kin or assignees ("Entrant's Representatives") may have or which may hereinafter accrue to the entrant or Entrant Representatives against the Released Parties as a result of the entrant's participation in the Contest or the receipt or use of the Prize awarded herein.

The following are prohibited and will result in automatic disqualification from the Contest: (1) using any method that artificially increases odds of winning; (2) non-compliance with the Contest Rules; and (3) any other act which the Contest Sponsor determines, at its sole and absolute discretion, jeopardizes the integrity of the Contest.

The Releasees are not responsible for any printing, distribution or production errors, or for any late, lost or misdirected entries. The Contest Sponsor may terminate, modify, waive, suspend or withdraw from the Contest (and/or any aspect thereof, including methods for selection of the Winner), in whole or in part, at any time without notice for any reason, without liability, at its sole and absolute discretion.

The Releasees shall not be responsible for tampering, theft, human errors (including gross negligence) ineligibility, lost, late or misdirected entries or for any problems, failures or technical malfunctions of any telephone network or lines, computer online systems or servers, computer software problems or traffic congestion on the internet, or at any website and assume no liability for damage to an entrant's or any person's computer or mobile device resulting from participating in the Contest or the failure of the Contest Sponsor to process any entry and otherwise award the Prize. Nor is responsibility assumed by the Releasees for printing errors appearing in the Contest Rules, or related Contest materials. In addition, the Releasees will not assume any responsibility of any nature whatsoever in all cases where their inability to hold the Contest or to remit the Prize to the Winner results from a cause beyond their control, including weather conditions, acts of God, acts of terrorism, civil disturbance, any other natural disaster outside their control, work stoppage, lock-out or other labour dispute, or any other reason. Any attempt to deliberately damage any website or to undermine the legitimate operation of this Contest is a violation of criminal and civil laws, and should an attempt be made, the Contest Sponsor reserves the right to seek remedies and damages to the fullest extent permitted by law, including criminal prosecution.

As a condition of participating in this Contest, each entrant agrees that (i) any and all disputes, claims, controversies or causes of action arising out of or relating to this Contest, or any Prize awarded (each, a "**Claim**"), shall not be consolidated or joined with or in any other proceeding involving a Claim of any other party; and (ii) under no circumstance will the entrant be permitted to obtain awards; and (iii) the entrant hereby waives all rights to claim, punitive, incidental, consequential or any other damages, other than for actual out-of-pocket expenses.

In the event of any discrepancy or inconsistency between the terms and conditions of the Contest Rules and disclosures in other statements contained in any Contest related materials, the terms and conditions of the Contest Rules shall prevail and govern.
